Advantages of Cleary's 3336F over OM Scott's Fungo FLO

1. Better Shelf Life—3336F was reformulated in 1996 to improve the shelf life that a user can expect. Improvements seen in accelerated aging studies show that 3336F should be usable for three years or more, while Fungo FLO will be usable two years or less.

2. Better Formula—In the 1996 reformulation, the particle size of 3336F was reduced to 2-3 microns. Fungo FLO's particle size is 5-7 microns. Smaller particle size improves particle distribution on foliage and roots and improves absorption characteristics. Testing of other fungicides has shown the benefit of small particle size. Direct testing of 3336F to confirm is currently underway.

3. More Use Sites on the Label—3336F is labeled for use on greens, tees, fairways, parks, athletic fields, commercial turf, residential turf and cemeteries. Fungo FLO is NOT labeled for use on parks, athletic fields, commercial turf, residential turf and cemeteries.

4. More Turf Species on the Label—3336F is labeled for use on ALL turf species due to it's "such as" language on the label. Fungo FLO is specifically limited to just six turf species. For example, Zoysia grass is not on the Fungo FLO label.

5. More Diseases on the Label—3336F is labeled for use on Pink Snow Mold. Fungo FLO does not specifically mention "Pink Snow Mold."

6. More Effective Use Rate for Anthracnose—3336F is labeled for use at 4-8 oz. per thousand for Anthracnose. Recent research has shown that 4-8 oz. is necessary to effectively control this disease. Fungo FLO's label rate for this disease is 1-2 oz., which is often ineffective.

7. The 3336F Label is Continually Being Expanded—Due to research from 1996, the following diseases are in process of being added to the 3336F label: Gray Leaf Spot, Take All Patch, Zoysia Patch, Curvularia, Basal Rot Anthracnose, Spring Dead Spot and additional ornamental diseases.

8. MSDS Included with Every Container—Each container of 3336F includes a full use label AND a complete MSDS. Fungo FLO does not offer this feature.
