DIRECTIONS FOR USE FOLIAR APPLICATION RATES

Add Grigg Brothers Ultraplex™ to any Grigg Brothers foliar application at the rate of 3 fl. oz. per 1000 sq. ft. Ultraplex™ contains micronutrients. Ultraplex™ is a unique formula, no additional surfactant is required.

IMPORTANT: For best results apply as a foliar spray early in the morning or late evening. Allow to dry on plant 3-6 hours before irrigation. Apply with 1-2 gallons of water per 1000 sq. ft.

COOL SEASON TURF GRASSES: As a foliar - maintenance rate 3 oz. per 1000 sq. ft. weekly or bi-weekly as needed.

WARM SEASON TURF GRASSES: As a foliar - maintenance rate 3 to 6 oz. per 1000 sq. ft.

OPTIONAL: Add 3 oz. of Grigg Brothers Tuff Turf or Potassium to the tank mix for optimum uptake.

COMPATIBILITY: Jar test for compatibility when mixing with other chemicals.
